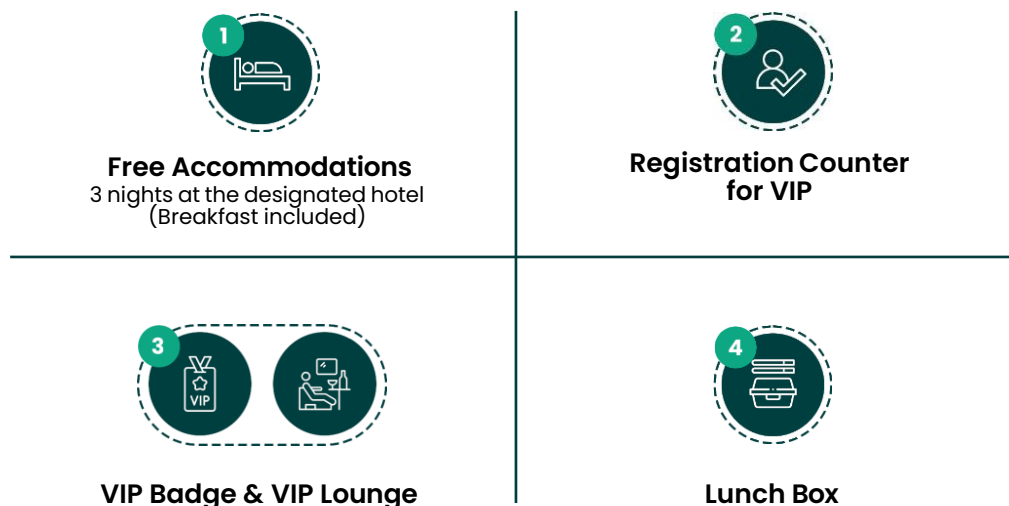

Terms and conditions;

- A copy of Hosted Buyer's passport and flight ticket should be submitted to the organiser for the hotel reservation

- If the hosted buyer fails to complete commitments above, the hotel fee will be charged to the hosted buyer
- Other personal expenses such as early or late check-in, extended nights and hotel mini-bar are not covered by the organiser

Who can Participate?

- Applicants with purchasing power or the authority to source pharmaceutical, biopharmaceutical, and nutraceutical products and services.

Commitments of Hosted Buyer

- ✓ **Exhibition Attendance**

 - Schedule all meetings in advance through Online Matchmaking Platform.
 - Submit a minimum of 6 meeting reports during the event.
 - Onsite staff may monitor meetings to prevent no-shows.
- ✓ **Punctuality**
 - Buyers must be on time and prepared before each meeting starts.
 - Frequent lateness or missed meetings may impact eligibility for future editions.
